1. <u>Preamble</u>

As per Section 135 of the Companies Act 2013 every company having any one of the below mentioned limits

- (i) Net worth of rupees five hundred crore or more, or
- (ii) Turnover of Rupees one thousand crore or
- (iii) Net profit of Rupees five crore or more

during any financial year shall constitute a Corporate Social Responsibility (CSR) Committee of the Board consist of three or more directors, out of which at least one director shall be an independent director.

In lieu of the above provision, as on March 31, 2015, the Net Profit Dr. Agarwal's Eye Hospital Ltd (hereinafter referred to as "the Company") is more than the above specified limit as mentioned under criteria (iii) of Section 135 of the Companies Act, 2013 and therefore the Company has constituted a CSR Committee and has to formulate a CSR Policy.

2. Introduction

The Board of Directors ("The Board") of Dr. Agarwal's Eye Hospital Ltd (hereinafter referred to as "the Company") has adopted the following policy and procedures with regard to Corporate Social Responsibility. The Board may review and amend this policy from time to time subject to recommendations of Corporate Social Responsibility committee.
